Assumption of the Risk and Waiver of Liability Relating to Coronavirus/ COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, provincial, and local governments such as the Regional Municipality of Ottawa and federal and provincial health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

Riverview School of Music (RSOM) has put in place preventative measures to reduce the spread of COVID-19 at its rehearsals and performances however, RSOM cannot guarantee that you or your child will not become infected with COVID-19. Further, attending lessons and recitals could increase your risk of contracting COVID-19.

I understand that this Assumption of the Risk and Waiver of Liability agreement is in addition to, and is not a substitute for, any other documentation or registration information that I might be required to execute by the Regional Municipality of Ottawa or RSOM.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that I may be exposed to or infected by COVID-19 by attending the rehearsals, performances or similar activity and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at lessons, recitals, or similar activities may result from the actions, omissions, or negligence of myself and others, including, but not limited to, RSOM, including the instructors, teachers, coaches, administration staff, as well as, Lost Baggage Musical Theatre.

I acknowledge that I have received training from RSOM on COVID-19 prevention in regards to lessons and recitals and understand the additional protocols and prevention procedures required of me. I agree to do my best to adhere to these protocols and prevention procedures when I or my child is at RSOM. I also understand the risk of infecting others and spreading COVID-19 outside of RSOM business and events and will do my best to comply with municipal, provincial and federal COVID-19 guidelines and protocols.

I VOLUNTARILY AGREE TO ASSUME ALL OF THE FOREGOING RISKS AND ACCEPT SOLE RESPONSIBILITY FOR ANY INJURY TO MYSELF (INCLUDING, BUT NOT LIMITED TO, PERSONAL INJURY, DISABILITY, AND DEATH), ILLNESS, DAMAGE, LOSS, CLAIM, LIABILITY, OR EXPENSE, OF ANY KIND, THAT I MAY EXPERIENCE OR INCUR IN CONNECTION WITH MY ATTENDANCE TO ANY REHEARSALS OR PERFORMANCES OR SIMILAR ACTIVITIES DURING THE PARTICIPATION OF ANY ACTIVITIES AND LESSONS HOSTED BY RIVERVIEW SCHOOL OF MUSIC. ON MY BEHALF, I HEREBY RELEASE, COVENANT NOT TO SUE, DISCHARGE, AND HOLD HARMLESS TO RIVERVIEW SCHOOL OF MUSIC OF AND FROM THE CLAIMS, INCLUDING ALL LIABILITIES, CLAIMS, ACTIONS, DAMAGES, COSTS OR EXPENSES OF ANY KIND ARISING OUT OF OR RELATING THERETO.

I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of RSOM, any individuals while participating in activities and lessons hosted by RSOM, as well as Lost Baggage Musical Theatre, whether a COVID-19 infection occurs before, during, or after participating in the activity or lesson.
